• **Biographical History**: Kenneth Roberts worked as curator for the American Watch and Clock Museum in Bristol, Connecticut. He collected manuscripts on "Connecticut Clocks 1840/1880" for a book. He had his own publishing company called Kenneth Roberts Publishing, which published books on clocks and horology.

Content & Structure

Scope & Content: This collection consists of correspondences between Roberts and
other individuals as well as letters written to Roberts concerning family clocks. Also in
the collection are: photographs of clocks, photocopies of the American Watch Company,
photocopies of Patents and illustrations, research requests to the United States Patent
Office and the New York Historical Society, maps, and portraits of C. Jerome and E.
Ingraham.
